# About Backup Exec Utility

Use the Backup Exec Utility, beutility.exe, to perform various configuration. It is installed in your Backup Exec working directory during the initial Backup Exec installation.

With the Backup Exec Utility, you can do the following tasks:

- Add, remove, and configure logical groups of Backup Exec servers. With logical groups, you can perform operations on all of the computers in a group at the same time. These operations include starting or stopping services and configuring application service security, such as changing service account information. You can also use the Backup Exec Utility to configure startup options for one or more of the servers in a group.
- Start immediate database utility operations on the Backup Exec Database (BEDB). The database maintenance utilities usually initiate these utilities. You

can start database dumps and run database consistency and data integrity checks.

Note: You should use the Backup Exec Utility only with the guidance of Technical Support. Improper use of this utility can result in configuration changes that may prevent Backup Exec from running.

#### To add a new computer running the Backup Exec Agent for Windows

- In the Computers pane, expand Known Computers.
- 2 Click All Agent for Windows Computers.
- 3 In the task pane, under General Tasks, click New Agent for Windows Computer.
- Type the name of a computer running the Backup Exec Agent for Windows, or click **Browse** to navigate to the computer.
- 5 Click OK.

New Backup Exec Server Group lets you create a container where you can logically group together multiple Backup Exec servers. After you create a group, you can add Backup Exec servers to it by using the Add Server task.

When you add Backup Exec servers to a group, you can perform operations on the entire group at the same time.

# Deleting a Backup Exec server from the Backup Exec Utility list of known Backup Exec servers

Delete Backup Exec server lets you remove Backup Exec servers from the Backup Exec Utility master list of known servers. Backup Exec servers that are on the master list appear in All Backup Exec Servers. Deleting a Backup Exec server

from All Backup Exec Servers does not affect the operational status of the Backup Exec server.

You cannot use **Delete Backup Exec Server** to remove Backup Exec servers from Backup Exec Server Groups.

# Deleting a computer on which the Agent for Windows is installed

Delete Agent for Windows Computer lets you delete the computers that are running the Agent for Windows from All Agent for Windows Computers. Using this option does not uninstall the Agent for Windows from the computer.

To delete a computer on which the Agent for Windows is installed

- In the Computers pane, click All Agent for Windows Computers.
- 2 In the task pane, under General Tasks, click Delete Agent for Windows Computer.
- Select a computer to delete.
- 4 Click OK.

# Deleting a Backup Exec server group

Delete Backup Exec Server Group lets you remove user-defined Backup Exec server groups from Backup Exec Server Groups.

All Backup Exec servers that are contained in the Backup Exec server group are deleted along with the Backup Exec server group itself. Although they are deleted from the group, the deleted Backup Exec servers are not removed from All Backup Exec Servers.

#### To delete a Backup Exec server group

- 1 In the Computers pane, click Backup Exec Server Groups.
- 2 In the task pane, under General Tasks, click Delete Backup Exec Server Group.

- Select a Backup Exec server group or groups to delete. See "Delete Backup Exec Server Group" on page 16.
- Click OK.

### Delete Backup Exec Server Group

Delete Backup Exec Server Group displays an existing list of Backup Exec server groups that you can delete from **Backup Exec Server Groups**.

Note: All Backup Exec servers that are contained in the Backup Exec server group are deleted along with the Backup Exec server group itself. Although they are deleted from the group, the deleted Backup Exec servers are not removed from All Backup Exec Servers.

# Running Backup Exec diagnostics

BE Diagnostics starts the Backup Exec Diagnostics application on the Backup Exec servers that appear in the Backup Exec Utility.

Backup Exec Diagnostics gathers information about Windows computers for troubleshooting purposes. You can find this application in the Backup Exec directory on your hard drive. The default location of the Backup Exec Diagnostics application is <Backup Exec install path>\Backup Exec\.

#### To run BE Diagnostics

- Select a Backup Exec server from either a Backup Exec server group or from All Backup Exec Servers.
- 2 In the results pane, select a Backup Exec server.
- 3 In the task pane, under **General Tasks**, click **BE Diagnostics**.

BE Diagnostics sends its output to an ASCII text file called bediag.txt. You can find this text file in the default Backup Exec installation directory:

<Backup Exec install path>\Backup Exec\

# Enabling debug logs

Enable Debug Logs lets you activate Backup Exec debug routines for a variety of Backup Exec services. In addition, Enable Debug Logs also creates debug log files that are stored on a Backup Exec server hard drive.

You should only use Enable Debug Logs when Technical Support needs specific information about your Backup Exec installation. Activating debug logging greatly affects Backup Exec server performance.

In a default installation, Backup Exec log files reside in the Logs directory, in the following path:

<Backup Exec install path>\Backup Exec\Logs

If you install Backup Exec to a different path, use that path instead.

#### To use the Enable debug logs task

- Select a Backup Exec server from either a Backup Exec server group or from All Backup Exec Servers.
- 2 In the task pane, under General Tasks, click Enable Debug Logs.
- Set the appropriate options. See "Enable debug log configuration options" on page 17.
- Complete the debug log configuration options as directed by technical support.

Set Debug Log Size and Location lets you set the maximum size of the log files that are generated for the following Backup Exec services:

- Backup Exec Server
- Backup Exec Job Engine
- Backup Exec Remote Agent for Windows

#### To enable communications with the managed Backup Exec server

- Start BEUtility on the central administration server.
- 2 Select a paused managed Backup Exec server from either a Backup Exec server group or from All Backup Exec Servers.
- In the task pane, under CASO Tasks, click Enable Communications with the Managed Backup Exec Server.
- 4 Click **Yes** to confirm the stopping and restarting of the Backup Exec services.
- 5 When the operation finishes, click **Close**.

### Disabling communication with the managed Backup Exec server
