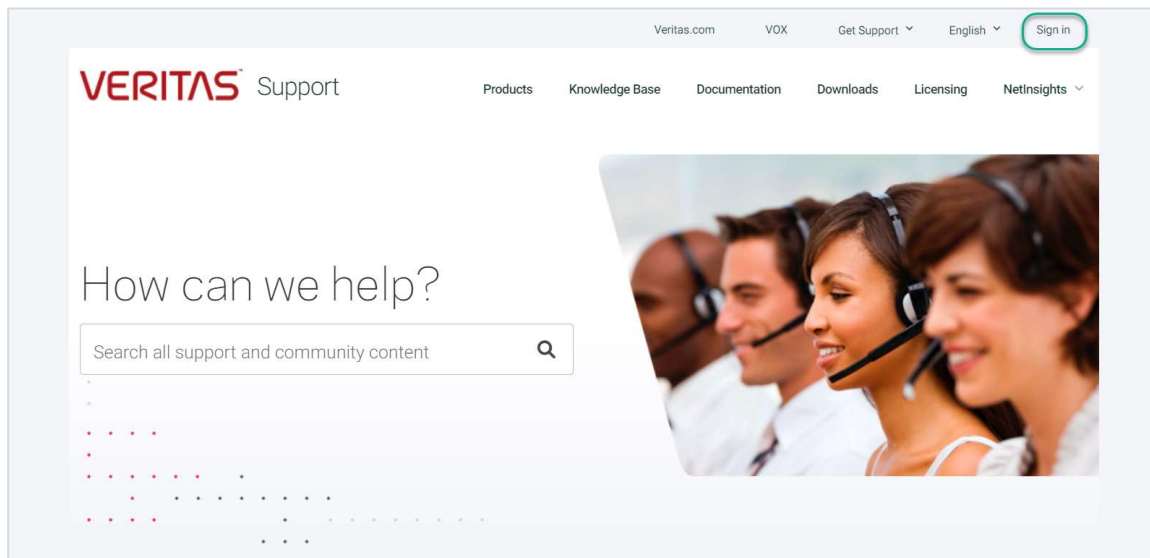

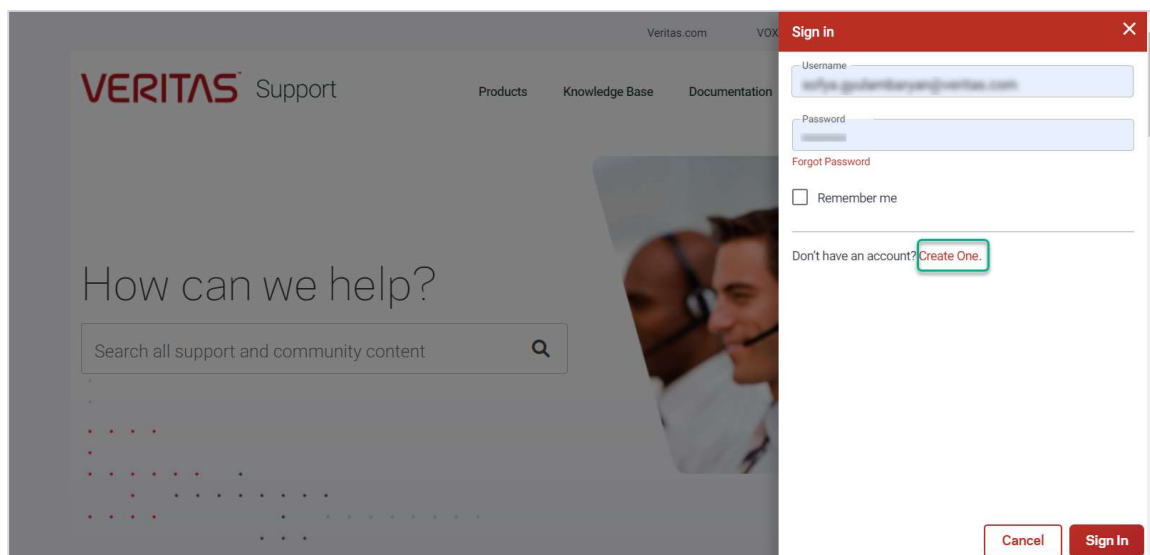

3. If you do not have an account, click **Create One**.





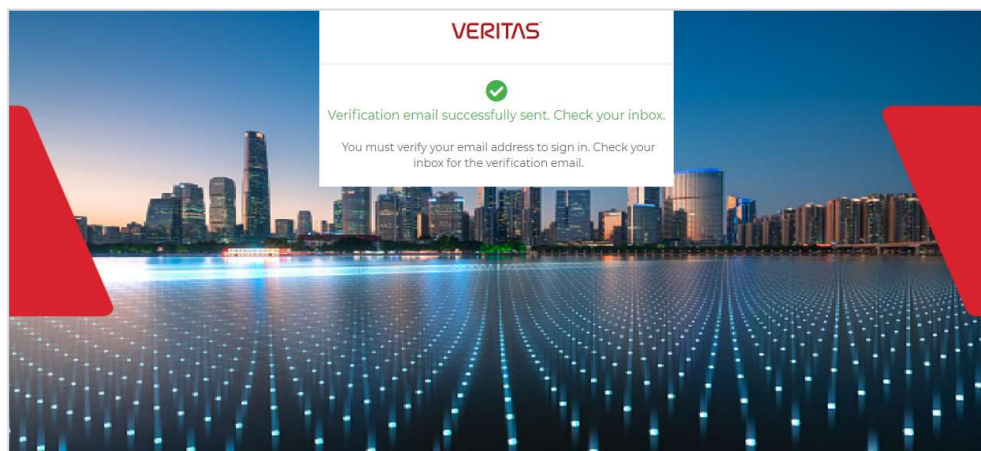

12. Check the box next to each file that you wish to download and click 'CloudLink 4.1.2 64-bit' or 'CloudLink 4.1.2 32-bit.'

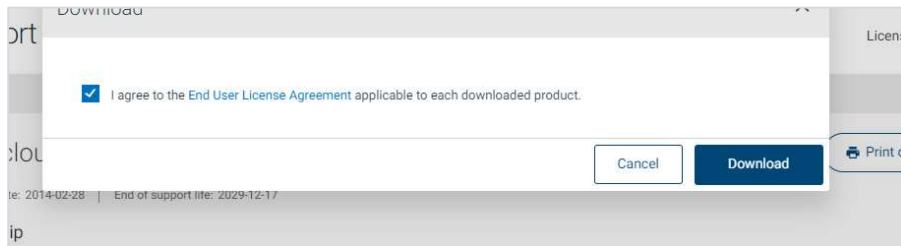
